

# European Hardened Timber Flooring Residential Warranty

# **General Warranty Conditions**

For these warranties to apply, Belgotex New Zealand Limited (Belgotex NZ) Parky European Hardened Timber Flooring must be installed according to the manufacturer's installation instructions published on the Belgotex NZ website. Your Parky European Hardened Timber Flooring must also be maintained, as published on the Belgotex NZ website. These warranties are extended to the original purchaser only and are not transferable. Claims must be submitted to the original place of purchase and proof of purchase must be supplied for any claims, with installation dates.

Parky European Hardened Timber Flooring is only intended for normal internal use in an occupied timber-friendly environment. Window treatments to protect your floor are recommended in positions where intense direct sunlight could adversely affect your floor.

## **Residential Warranty**

These warranties are effective from the date of purchase and are backed by a comprehensive Residential Wear Warranty. The collections offer a 35-year Residential Wear Warranty.

## **Scope of Residential Wear**

Wear defects are considered as visible wear through the wear layer which covers a surface of at least 10 mm x 10 mm during the wear warranty period. Proper installation in accordance with Installation Instructions and consistent adherence to Care & Maintenance instructions are mandatory to maintain warranty validity. These documents are available from your retailer or the Belgotex NZ website - <u>belgotex.co.nz</u>.

## **Moisture Protection Warranty**

Parky European Hardened Timber Flooring ranges come with a 15-Year Moisture Protection Warranty. All Moisture Protection Warranties are effective from the purchase date.

## **Scope of Moisture Protection Warranty**

The moisture protection warranty covers water-induced surface damage, excluding issues from appliance malfunctions or extensive flooding. Compliance with installation, maintenance instructions and MBIE building codes is required. Water spills must be cleaned up within 24 hours to maintain the warranty.

## **Underlay Specifications**

Underlay plays a crucial role in the performance and longevity of your Parky European Hardened Timber Flooring. To ensure optimal results, it is essential to use underlays that meet the following specifications. Specifications must be equal to or greater than Parky specifications, or, if not specifically indicated by Parky, must conform to the minimum specifications as laid out by the Multilayer Modular Flooring Association technical bulletin 1, which are necessary to maintain the warranty:

#### Specific reference to following performance:

- Compression Strength (CS): Underlays should have a compression strength of at least ≥ 40 kPa.
- Water Vapour Diffusion Resistance (SD): The SD value should be a minimum of  $\ge$  75 m.

These specifications are crucial to uphold the warranty conditions. Proper underlay selection will enhance the durability and performance of your flooring system, contributing to its long-term success. Underlay must be installed in accordance with the installation instructions, failure to correctly install underlay may result in voiding the warranty.

## **Direct Stick Installations**

Parky European Hardened Timber Flooring can be installed using the direct stick method, which involves adhering the flooring indirectly or directly to the subfloor. To ensure optimal performance and maintain your warranty coverage, please adhere to the following guidelines:

## **Moisture Membrane Installation**

#### Mandatory Moisture Barrier:

Regardless of the subfloor's moisture content, a continuous moisture membrane must be installed. This is crucial to prevent moisture-related issues that can affect the flooring.

#### **Compliance with Standards:**

The moisture membrane and adhesive system should comply with relevant New Zealand standards, NZS AS 1884-2013.

# **Use of Appropriate Adhesive Systems**

#### Selecting the Right System:

While 2-in-1 moisture barrier and adhesive systems are available, it's essential to ensure they are suitable for your specific subfloor conditions. Some products are only appropriate for concrete subfloors with moisture levels up to 95% relative humidity (RH).

#### Manufacturer's Guidelines:

The moisture membrane and adhesive system should comply.

# **Warranty Information**

Our warranty covers the European Hardened Timber Flooring when installed and maintained according to our guidelines and industry best practices. Please note:

## What is not covered by Parky's warranty

#### **1. External Factors and Accidents**

#### **Environmental Damage:**

Damage caused by flooding, appliance malfunctions, or other water ingress.

Discoloration or fading due to prolonged exposure to sunlight or UV light. (We recommend using window coverings or UV-protective films to minimize this effect.)

#### Accidental Damage:

Surface scratches, chips, dents, or other mechanical damage resulting from accidents or misuse. This includes impacts from high heels, dragging heavy objects or furniture, sand, stones, castor wheels, and dropped items. Permanent stains or surface marks caused by substances not intended for use on timber flooring.

#### 2. Natural Characteristics of Timber

#### **Normal Variations:**

Minor gloss variations between boards.

Natural wood features such as gum veins, insect trails, small splits or checks, sapwood, knots, and medullary rays. These are inherent characteristics of natural timber and contribute to its unique appearance.

#### **Seasonal Movement:**

Small gaps between boards caused by environmental changes like humidity and temperature fluctuations. This is a normal behavior of timber flooring and may be addressed by professional filling if necessary.

#### 3. Installation and Maintenance Improper

#### Installation or Maintenance:

Issues arising from incorrect installation practices that are not in accordance with our guidelines.

Wear or damage linked to improper or insufficient maintenance. (Please refer to our care instructions for proper maintenance procedures.)

#### **Panel Height Variations:**

Minor height differences between panel edges are to be expected.

#### 4. Pest Infestation

#### **Post-Installation Damage:**

Damage resulting from insect or borer activity occurring after the flooring has been installed.

# **Product Characteristics and Care**

Parky European Hardened Timber Flooring is designed to be resistant to chips, scratches, stains, and wear. However, it is not entirely invulnerable to damage, and reasonable care should be taken to prevent scratches, chips, and other forms of wear. Natural characteristics of timber flooring may include:

#### **Gloss Variation:**

Slight differences in gloss levels between boards may occur due to natural variations in the timber.

#### Seasonal Movement:

Changes in humidity and temperature can cause the timber to expand or contract, leading to small gaps between boards. These characteristics are normal for timber flooring and add to its natural beauty.

## **Consumer Rights**

Nothing in this warranty is intended to reduce or diminish your rights under the Consumer Guarantees Act 1993. We are committed to honoring all statutory obligations, including those related to product quality and performance.

## **Installation Warranties**

This warranty covers the manufactured goods only. For warranties related to installation, please consult the installation company or individual who completed the installation.

## Claims

If your Parky European Hardened Timber Flooring fails to perform in line with any of the Belgotex NZ Warranties or the Consumer Guarantees Act 1993 (CGA), Belgotex NZ will, in accordance with our obligations under the CGA:

Replace the defective Parky European Hardened Timber Flooring with flooring of the same or comparable quality; or

Provide a Credit towards the cost of replacement Parky European Hardened Timber Flooring, determined as a percentage of the original purchase price (see the table below).

The remedy provided by Belgotex NZ will cover the affected area and may include reasonable installation costs. We are committed to honoring all our obligations under the CGA, ensuring you receive a fair and effective remedy.
